CERTIQUALITY was established in 1989 by Federchimica and Assolombarda and has a number of ordinary partners representing the Trade Associations, and statutory partners vouching for the soundness and fairness of its dealing.

# ACCREDITATION

CERTIQUALITY is accredited by Accredia in compliance to International standards EN 45011 e ISO 17021 for Certification bodies.

ACCREDIA has been appointed by the Italian Government on 22th December 2009 as National Accreditation Body that performs accreditation with authority derived from the State. ACCREDIA evaluates the technical competence and professional integrity of the conformity evaluation operators (laboratories and bodies), evaluating compliance with mandatory regulations and voluntary standards in order to ensure the value and reliability of the attestations they release.

CERTIQUALITY is the first italian Certification Body to be accredited on ISO 14001 and 50001.

# CERTIQUALITY - IQNET

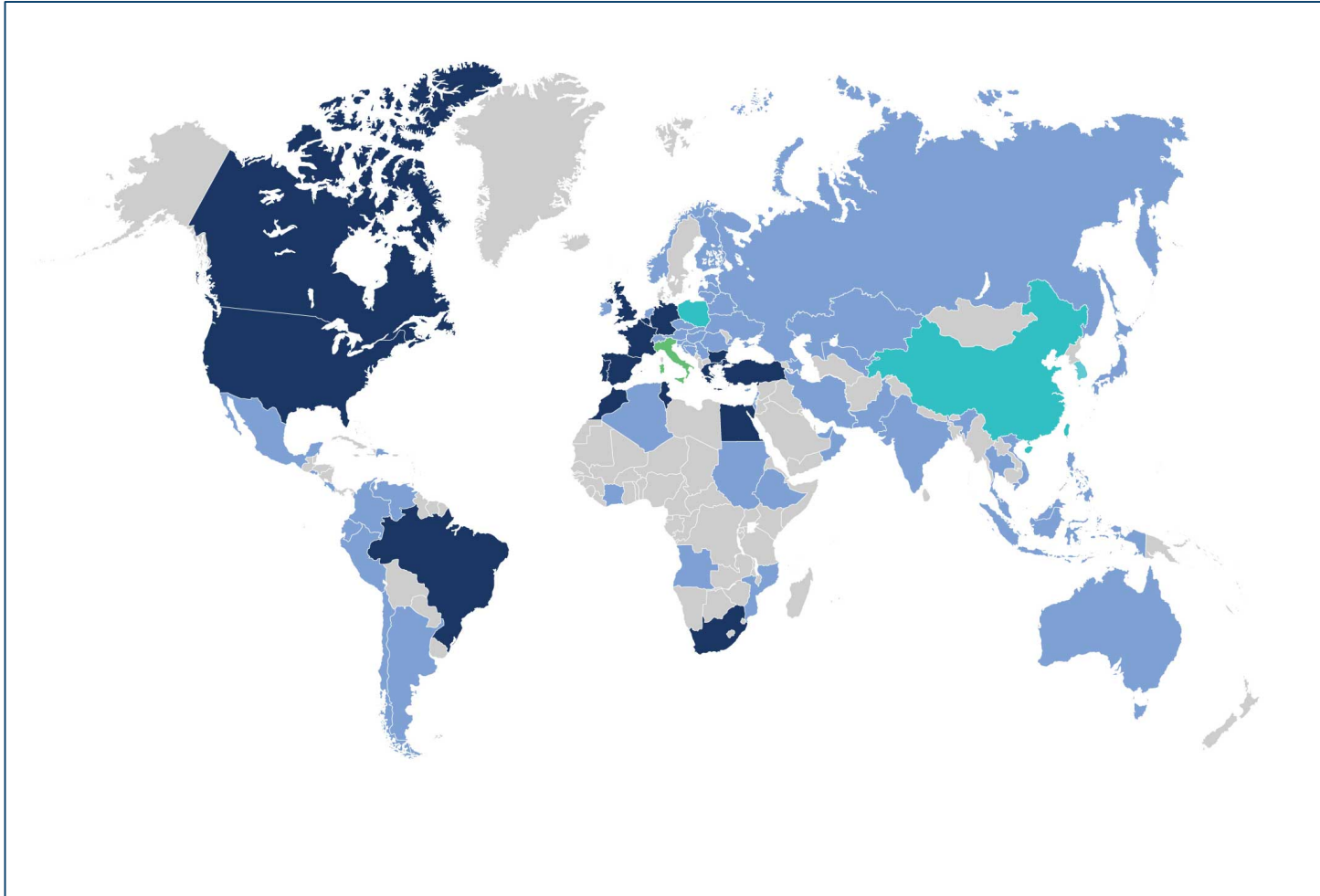
